2. **OSR Corrections:** All officers, particularly those eligible for augmentation or other selection boards, are strongly encouraged to ensure that their Officer Summary Record (OSR) is up-to-date and accurate. OSRs are available on “Bupers ONLINE” - www.bol.navy.mil <<http://www.bol.navy.mil>>. There are two items that are frequently missing - bar information and education/degree information. Below are instructions on how to correct each:

a. **Bar information:** The “Special Qualifications” section of the OSR should list each bar membership. If your OSR is missing one or more bar membership, send (fax or email is fine) to your detailer a document that shows the state you are admitted to and what year you were admitted.

b. **Education/Degree information:** The education section of your OSR should list each degree you have been awarded; for JAGs, this should include at least a bachelor’s degree and a juris doctorate. To add missing degrees:

- 1) Sign on to Bupers ONLINE (www.bol.navy.mil <<http://www.bol.navy.mil>>)
- 2) Click on “ODC, OSR, PSR, ESR”
- 3) Click on “Officer Data Card (ODC)”
- 4) Enter appropriate email and phone, then click on “build and view ODC”
- 5) Click on “Education Section” at the top
- 6) In the “Formal Education” section, click on “Click Here to Add a New Line”, then follow directions for inputting specific education data.
- 7) Once you complete the data entry, you will get an email. Print the email, then fax it, a copy of your transcript(s), with a short cover letter to: NSIPS, fax # DSN 647-0342/(504)697-0342. [NOTE - the email will instruct you to fax the info to PERS 312G - this is INCORRECT - fax to NSIPS at the above number]
- 8) You will then receive email from NSIPS confirming receipt and an estimated time of completion. After that estimated time of completion, check your OSR again to make sure the entry was correct.
