1. The FY05 JAG Corps Promotion Phasing Plan is attached. Remember, phasing dates are only projections. Actual promotion dates are announced in NAVADMIN messages.
2. Code 61 maintains a personnel data base for management of the JAG Corps. We now have the ability to allow individual officers to update their personal info and biographies, and also upload their official photographs.

The JAG Enterprise System can be accessed at <<https://enterprise.jag.navy.mil>>. At the official login screen, User Name, the officer needs to enter his or her last name, first name and middle initial in the following format: sailor.ben.e or sailor.ben if no middle name. For the Password field, the officer should enter his or her last name (initial character must be capitalized) and 4-digit year of birth. For example, Sailor1961. After entering this information, the officer will then be prompted to change his or her password. After changing their password, the officer should once again log on to the system and select My Profile from the menu. The officer can then review and update his or her own personal and contact information. After updating their personal information, they should select the Biography, Update menu, which will allow them to both upload their biographical information and official photograph. There is a newly created vacancy for an Assistant Counsel position in the Office of Counsel for Commander, Navy Region Northeast (CNRNE), located aboard the Naval Submarine Base New London, Groton, Connecticut. The position is rated GS 11 through 14. This position will close 5 November 2004 and applications must be received by that date.

CNRNE provides base operating support at several installations in the Northeast. The primary individual installations include Naval Air Station Brunswick, Maine; Portsmouth Naval Shipyard, Kittery, Maine; Naval Station Newport, Newport, Rhode Island; Naval Support Activity, Saratoga Springs, New York; Naval Submarine Base New London, Groton, Connecticut; Naval Weapons Station Earle, Colts Neck, New Jersey; Naval Air Engineering Station, Lakehurst, New Jersey and other smaller installations and activities. Office of Counsel, CNRNE provides legal advice to the Regional Commander, Base Commanding Officers and Program Directors in a wide range of OGC practice areas. Particular practice areas include civilian personnel law, real estate, labor relations,

strategic sourcing, privatization, NAFI and MWR operations, fiscal law, procurement, ethics and FOIA.

The successful candidate will have highly developed interpersonal skills, the ability to work with both military and senior civilian officials, keen analytical skills and a strong work ethic. The position will be filled at the GS-11 through GS-14 level depending upon the qualifications of the candidate selected. To be eligible at the GS-11 level, the applicant must be licensed by a state bar and have some educational experience or training in one or more of the areas of practice. To be eligible at the GS-12 level, the applicant must have a minimum of one year of legal experience or training. To be eligible for selection at the GS-13 level, the applicant must have experience or training in one of the practice areas identified above. To be eligible for selection at the GS-14 level, the applicant must have experience or training in most of the practice areas. Experience and/or training in the area of civilian personnel law matters will be considered a plus.

Applicants should submit: a resume or OF-612; a brief supplemental statement as to their interest in, and qualifications for, the position; two writing samples; and either the performance evaluations for the last two years or law school transcripts. Applicants who have graduated from law school within the past five years must provide a law school transcript. Applications should be sent to:
